  - c. That I/we shall not be entitled to any refund of amounts, which have been withdrawn while this authority was in force if such amounts were legally owed.
  - d. That although this Authority and Mandate may be canceled by me/us by giving 30 days' notice in writing and sent by registered post, such cancellation will not cancel the original Agreement.
  - e. That this authority may be ceded or assigned to a third party if the Agreement or the management of the Agreement is also ceded or assigned to that third party, but in the absence of such assignment of the Agreement or management of the Agreement, this Authority and Mandate may not be assigned to any third party.
